It is my pleasure to announce that the Leucadia Wastewater District (LWD) had a successful evening at the recent California Water Environment Association (CWEA) – San Diego Section's Annual Installation and Awards Banquet. LWD was honored to receive the following two awards: Collection System of the Year (0-249 miles), and Collection System Person of the Year. A brief summary of each award follows:

2023 Collection System of the Year (0-249 miles)

This was the 10th time LWD has received the Collection System of the Year Award. One of the highlights that helped LWD win this award included our innovative solution to challenges, such as, a unique priority rating system for rehabbing or replacing defective sewer lines or manholes. LWD also uses a regular schedule of hydro-cleaning and Closed-Circuit Television (CCTV) inspections of the collection system as an effective preventive measure against FOG accumulation within the pipelines. LWD's Collection System also emphasizes employee safety as a priority. LWD has an active Safety Committee that meets quarterly to review safety programs, conduct safety inspections, draft new programs if required, and correct any safety items found in previous inspections to prevent future accidents.

The Collection System of the Year Award qualifies as a local award under the organizational objectives of the LWD's Incentive Program; therefore, staff is eligible for a \$100 incentive award.

2023 Collection System Person of the Year Award

Mr. Hugo Gonzalez, a Field Service Technician III, received the Collection System Person of the Year Award. Hugo has been employed at LWD since September 2013. In achieving this award, the selection committee recognized the fact that Hugo is highly motivated and possesses a strong work ethic.

Hugo takes a proactive stance to help improve daily operations and looks for ways to improve our processes to achieve our goals of environmental protection and the protection of public health. Hugo was recognized, in part for his ability to multi task and be a team player for the District's award winning collection system. Hugo also took the lead on a night work project to CCTV and hydroclean sewer trunk lines on El Camino Real (Heavy Traffic Road) and Hugo also was part of a FOG inspection team that exceeded the goal for yearly FOG inspections.

16. Proposed Resolution No. 2411 - Board of Directors Election of Board Officers, Establishment of Committees and Selection of Committee Members Policy

DFA Green stated that at the December 13, 2023 Board Meeting the Board directed staff to update the Policy for the Election of Board Officers, Establishment of Committee and Selection of Board Committee Members with an amendment which reflects that the LWD Board President and Vice President serve as LWD's representatives on the Encina Wastewater Authority (EWA) Board of Directors/Joint Advisory Committee (JAC) and, as such, shall serve staggered two-year terms.

DFA Green noted that during the development of the draft policy, staff realized that appointment of the EWA Board/JAC Alternate was not addressed in the Board's discussion. He then reviewed three options for the Board's consideration for determining the EWA Board/JAC Alternate.

Option 1: Designate the General Manager as the EWA/JAC Alternate.

- **Option 2:** Designate the LWD Board member next in line for Vice President as the EWA/JAC Alternate.
- **Option 3:** The President appoints a Board or staff member to EWA/JAC Alternate.

DFA Green stated that staff is requesting that the Board designate its preferred option, or hybrid thereof, for inclusion in the adopted policy.

Director Omsted stated that he thinks the EWA Board/JAC Alternate should be an elected official and should be someone with EWA knowledge and experience. He stated that he would like the previous LWD Board President to be the EWA Alternate which would be Director Sullivan.

18. Recycled Water Follow-up

GM Bushee presented the item and provided background information noting that at the October 11, 2023 Special Meeting, the Board of Directors reviewed the District's and EWA's Recycled Water programs. However, due to time constraints, the review of EWA's program was not completed. GM Bushee then provided a brief recap of the October 11, 2023 Special Board meeting.

GM Bushee stated that the goal of this discussion to determine whether the LWD Board wanted

to take an official position on EWA's water recycling plans. He then presented a summary of the findings from EWA's 2018 Water Reuse Feasibility Study, highlighting the top three preferred potable reuse options. The estimated capital cost for all three options was in excess of \$500 million in 2018 and the costs in today's dollars would likely be much higher. The annualized capital and operating costs were estimated between \$48 million and \$56 million depending on the option.

GM Bushee stated that LWD has been authorized by the state to provide retail wastewater treatment services and that all EWA's options are designed to develop potable water. EWA's estimated cost for developing potable reuse water presents a potential financial risk to LWD especially if the potable water cannot be sold for the cost to produce it. If this were the case, LWD would be subsidizing the potable water supply which is outside LWD's service function and would potentially be a violation of state Proposition 218. GM Bushee added that EWA staff has established a loose coalition of potential stakeholders called One Water North County, however, none of the stakeholders have committed to purchasing the potable reuse water to date. He added LWD could support a potable reuse project if it were cost neutral for LWD ratepayers.

GM Bushee noted that EWA is currently undertaking a potable reuse pilot project and study with an associated cost of \$1.6 million. This cost is partially offset by a federal grant in the amount of \$800,000. Through its membership at EWA, LWD has already committed to its share of the funding for the 2018 Feasibility Study and pilot project in the amount of \$320,000. GM Bushee then reviewed potential positions LWD could take pertaining to EWA's Potable Reuse Plans moving forward.

The Board discussed LWD's options at length. Several questions and comments were made regarding whether LWD should continue to fund EWA's potable reuse efforts, whether a new and lower ownership share could be negotiated for these facilities, and how LWD should approach this issue at EWA. Following discussion, the Board reached unanimous consensus to take an agency-wide position that LWD would support EWA's Potable Reuse Project as long as it is cost neutral to LWD and all future expenses beyond the current pilot project be paid by other parties who would benefit from the potable water produced. This position can be revisited if circumstances change such as change in regulations, commitments to purchase the water produced, etc.

Minutes of an Investment & Finance Committee Meeting February 6, 2024

A meeting of the Investment & Finance Committee (IFC) of the Leucadia Wastewater District (LWD) was held Tuesday, February 6, 2024 at 1:30 p.m. at the District office located at 1960 La Costa Avenue, Carlsbad, California.

1. Call to Order

Chairperson Pacilio called the meeting to order at 1:32 p.m.

2. Roll Call

3. Public Comment

No public comment was received.

4. Annual Review of LWD Reserve Fund Policy

DFA Green presented the recommendation indicating the purpose of the policy. He noted that the policy calls for annual review of the level of reserve funds by the Board of Directors. DFA Green stated that the Reserve Fund Policy was last revised in February 2023.

DFA Green then provided an overview of the fiscal year 2023 reserve activity.

DFA Green noted that staff had reviewed the Reserve Policy and is recommending a change to the policy. He then reviewed the change.

Wastewater Replacement Reserve Target Update

On June 14th the Board adopted the 2023 Wastewater Financial Plan Study which recommended the District update its Capital Replacement Reserve Target. Staff and IB Consulting recommend adjusting the Wastewater Capital Replacement reserve targets from a minimum requirement of the twenty-year average CIP to one year of the 5-year average of capital funding and a target of two years of the five-year average of capital funding. Capital costs may vary substantially based on the size of a specific project and the number of projects that need to be addressed in one particular year. Therefore, adjusting the capital reserve targets to what is planned over the next five years will ensure funding is available and adjusts with the ebbs and flows of the District's capital planning.

Following discussion, the IFC concurred with staff to recommend that the Board of Directors adopt a Revised Reserve Fund Policy.

5. Financial Plan Update

DFA Green introduced the item and explained the purpose of the Financial Plan. He stated that LWD updates its Financial Plan every 5 years because financial conditions and assumptions change over time. He noted that the most recent Financial Plan Update was completed in 2023 and staff does an internal update of the Financial Plan on an annual basis to see how actual results are tracking with the original projections.

DFA Green stated the financial plan model looks out over 20 years. He noted that information from the Fiscal Year 2023 (FY23) Audit and FY24 budgeted amounts were used to update revenues, expenses, and capital projections in the financial plan model. He then provided an overview on the following topics.

- Comparison of projected and actual revenues and expenditures;
- Comparison of projected and updated reserve balances; and
- Monthly Sewer Service Rate Comparison

DFA Green concluded that the District's finances remain strong, while maintaining low rates, and the District is tracking well with the Financial Plan. DFA Green also noted that the largest concern is the Encina Wastewater Authority's future capital plan and staff will continue to monitor LWD's finances closely.

This item was for informational purposes and no action was taken.

Proposition 218 Process and Schedule a Public Hearing to Consider Adoption of an Ordinance Increasing the Sewer Service Charges for Fiscal Years 2025, 2026, and 2027

DFA Green presented the item and provided background information noting that the District adopted a Financial Plan on June 14, 2023. He stated that the Financial Plan indicated that in order for the District to meet the projected future operating and capital expenditures necessary to maintain the integrity of its collection system, a three-year sewer rate increase would be needed beginning fiscal year 2025.

DFA Green explained that at the April 6, 2023 Special Board Meeting the Board directed staff to move forward with the planned three-year sewer rate increases for FY 25–27 and proceed with the Proposition 218 Notice process.

Chairperson Pacilio stated the draft Prop 218 Notice was well done and informative.

Following discussion, the IFC agreed to recommend that the Board of Directors authorize staff to proceed with the Proposition 218 process and schedule a public hearing to consider adoption of an ordinance increasing the sewer service charges for Fiscal Years 2025, 2026, and 2027.

GM Bushee noted that the newsletter would be distributed to residents prior to the public hearing to increase rates.

Mr. Bloom reviewed the production schedule.

Following discussion, the CAC authorized staff and RTP to proceed with the newsletter articles under the proposed production schedule.

DISCUSSION:

Tactical Goal: Financial/Finance Policy Reviews

This item was reviewed by the IFC at their February 6th meeting and the IFC concurred with staff to present this item for the Board's consideration.

In February 2005, the Board of Directors (Board) adopted Leucadia Wastewater District's (LWD) Reserve Fund Policy which established a means for LWD to ensure that sufficient funds are available for current operating and capital needs. The policy was last reviewed and revised in February 2023.

The Reserve Fund Policy establishes two distinct reserves at LWD: 1) Restricted Reserves and 2) Unrestricted Reserves. The policy also establishes various designations within each type of reserve and calls for an annual review of the reserve balances. This report constitutes that review.

Staff has reviewed the Reserve Fund Policy and is recommending the following change to the existing Reserve Fund Policy:

Wastewater Replacement Reserve Target Update

On June 14th the Board adopted the 2023 Wastewater Financial Plan Study which recommended the District update its Capital Replacement Reserve Target. Staff and IB Consulting recommend adjusting the Capital Replacement reserve targets from a minimum requirement of the twentyyear average CIP to one year of the 5-year average of capital funding and a target of two years of the 5-year average of capital funding. Capital costs may vary substantially based on the size of a specific project and the number of projects that need to be addressed in one particular year. Therefore, adjusting the capital reserve targets to what is planned over the next 5 years will ensure funding is available and adjusts with the ebbs and flows of the District's capital planning.

A copy of the policy and proposed resolution are attached for the Board's review.

During November 2023, the Board received the Annual Comprehensive Financial Report (ACFR) for the fiscal year ended June 30, 2022 that included the following reserve balances:

LEUCADIA WASTEWATER DISTRICT RESERVE FUND POLICY

Ref: 23-826224-8653

A. POLICY STATEMENT:

One key element of prudent financial planning is to ensure that sufficient funding is available for current operating, capital, and debt service cost needs. An additional critical element of fiscal responsibility is to anticipate and prepare for future funding requirements as well as for unforeseen disasters and other unforeseen events. The Leucadia Wastewater District (LWD) will at all times strive to have sufficient funding available to meet its operating, capital, and debt service cost obligations. Reserve funds will be accumulated and maintained in a manner, which allows LWD to fund costs consistent with LWD's adopted Asset Management Plan and Financial Plan, while avoiding significant rate fluctuations due to changes in cash flow requirements. LWD will also maintain an emergency reserve position that may be utilized to fund unexpected disasters or unanticipated major failures. The Board of Directors will annually review the level of reserve funds maintained.

B. DEFINITIONS:

<u>Restricted Reserves</u>: These reserves have restrictions on their use that are imposed by outside sources such as creditors, grantors, contributors, or laws or regulations of other governments.

<u>Unrestricted Reserves</u>: These reserves have no externally imposed use restriction. The use of Unrestricted Reserve funds is at the discretion of the Board of Directors. There are two categories of Unrestricted Reserves: Designated and Undesignated. At LWD, all Unrestricted Reserves have been Designated.

<u>Designated Reserves</u>: These reserves are set-aside for a specific purpose, which is determined by the Board of Directors. The Board of Directors also has the authority to redirect the use of these reserve funds as the needs of LWD change.

C. LEUCADIA WASTEWATER DISTRICT RESERVES:

LWD maintains the following reserve funds:

1.0 RESTRICTED RESERVE:

a) Encina Wastewater Authority Reserve:

LWD is a member agency of the Encina Wastewater Authority Joint Powers Authority (EWA). EWA maintains member agency deposits on hand for emergencies and unanticipated expenditures. Annually on May 1, EWA will prepare a one-year capital program cash flow budget. The EWA Reserve amount will be established using the District's proportional share of EWA's average one-month requirement of the capital program.

2.0 UNRESTRICTED DESIGNATED RESERVES:

 a) <u>Wastewater Operating Reserve:</u> Since the majority of operating revenues are received periodically over the fiscal year and operating expenses are incurred uniformly over the fiscal year, an operating reserve is necessary to fund those costs attributable to daily operations. To meet daily operational needs, LWD has established a Wastewater Operating Reserve balance at 33% of annual budgeted operating expenses.

b) Wastewater Replacement Reserve:

The Wastewater Replacement Reserve provides funds for capital replacement and refurbishment of existing wastewater facilities. These capital improvements are identified in LWD's adopted Asset Management Plan and Financial Plan. Wastewater Replacement Reserve funds accumulate in an orderly manner and are drawn down as required to fund capital replacement projects. To avoid abrupt sewer service rate changes, this reserve may be used to stabilize rates. The Wastewater Replacement Reserve shall target a value of two years of the 5-year average of not exceed the total 20-year capital replacement costs for wastewater facilities as identified in the Financial Plan. The minimum target shall be one year of the 5-year average of capital replacement costs yearly average of the 20-year capital replacement costs is the minimum target balance to ensure that LWD is able to fund capital replacements as they are scheduled or needed.

c) Recycled Water Reserve:

The Recycled Water Reserve will fund capital improvements and replacement of water recycling facilities. This reserve can also be used to fund operating expenses in the Recycled Water Fund whenever there is a shortfall of recycled wastewater sales revenue. These capital improvements are identified in LWD's adopted Asset Management Plan and Financial Plan. The Recycled Water Reserve shall not exceed the total 20-year capital replacement costs for water recycling facilities as identified in the Financial Plan.

d) Wastewater Emergency Reserve:

The Wastewater Emergency Reserve provides funds for emergency response for potential repair or replacement of capital facilities due to damage from a natural disaster or unanticipated major failure in a period when capital improvements funds have otherwise been purposely spent down to preset limits on planned projects. The Wastewater Emergency Reserve is at the discretion of the Board of Directors and is maintained at a level of \$7,500,000, which is based on the recommendation by LWD staff and the District Engineer (Exhibit A).

For further detail of the sources and uses of the above reserves, please refer to following section "D".

D. SOURCES AND USE OF FUNDS:

This section describes the sources and uses of funds for LWD reserves and includes maximum and minimum reserve balances and other informational notes.

Leucadia Wastewater District Discussion of Emergency Reserve Fund

Maintaining a Wastewater Emergency Reserve Fund (WERF) provides the benefit of having funds available for emergency response to repair and/or replace capital facilities due to natural disaster damage or unanticipated major failure in a period when capital improvement funds have otherwise been purposely spent down to preset limits on planned projects. Separately, Capital Reserve Funds will be accumulated in a planned manner through financing, setting aside a portion of sewer service fees, or a combination of both methods, as determined by Board policy.

The amount to be recommended for maintenance in the WERF has been evaluated and discussed by Leucadia Wastewater District (LWD) staff and the District Engineer. The following table lists some pros and cons for three potential levels of WERF.

BACKGROUND:

Tactical Goal: Financial/Sewer Rate Increase Notification & Hearing

This item was reviewed by the IFC at its February 6th meeting and the IFC concurred with staff to present this item to the Board.

The LWD Board of Directors adopted an updated Financial Plan Study on June 14, 2023. This plan provides critical information regarding required operating and capital expenditures for the next 20 years. The Financial Plan Study indicated that a sewer service charge increase was required beginning fiscal year 2025 in order for the District to meet the projected future operating and capital expenditures necessary to maintain the integrity of its collection system.

DISCUSSION:

Based on the Financial Plan Update tracking and previous proposed sewer rate increase discussions, the Board directed staff to move forward with the planned sewer service rate increase for fiscal year 2025 and proceed with the Proposition 218 Notice process.

Staff recommends that the Board of Director's authorize staff to proceed with the Proposition 218 process, set a public hearing to consider adoption of an Ordinance increasing the sewer service charges for Fiscal Years 2025, 2026 and 2027.

The Proposition 218 Notice is attached for the Board's review. This notice meets State legal and regulatory requirements and will be sent to the LWD customer base 45 days prior to the April public hearing as required.

Staff and the IFC recommend that the Board of Director's authorize the General Manager to proceed with the Proposition 218 process, set a public hearing to consider adoption of an Ordinance increasing the sewer service charges for fiscal years 2025, 2026 and 2027.

PUBLIC HEARING INFORMATION

A public hearing will be held on the proposed increases to sewer service charge rates in fiscal years 2025, 2026, and 2027.

The public hearing will be held on Wednesday, June 12, 2024 at 5 p.m. in the Boardroom located at 1960 La Costa Avenue Carlsbad, CA 92009

You are welcome to speak at the public hearing, but official protests must be made in writing. Oral comments at the public hearing will not qualify as formal protests. If you would like to protest the proposed increases, please submit your protest in writing by the close of the public hearing. You may hand deliver your written protest or mail it to the Leucadia Wastewater District at 1960 La Costa Avenue, Carlsbad, CA 92009. Protests must be signed by the property owner or ratepayer and include your printed full name, assessor parcel number, and rate you are protesting. One protest notice is allowed per parcel in calculating a majority protest to the proposed increase.

The Board of Directors will hear and consider oral testimony and written material submitted regarding the proposed rate increases at the hearing. If, by the close of the public hearing, written protests against the rate increase are not presented by a majority of property owners, the Board of Directors will be authorized to adopt an ordinance to increase the sewer rate charge. At the close of the public hearing, the Board of Directors will consider and may approve the rate increases. There is a 120-day statute of limitations for challenging the rates.

The time and place for this meeting will also be published in newspaper notices and posted on www.lwwd.org.

ABOUT LEUCADIA WASTEWATER DISTRICT

The Leucadia Wastewater District (District) was formed in April 1959 pursuant to the County Water District Law. Established as an Enterprise Special District, the District is authorized to provide wastewater collection and treatment services, and to levy rates and fees to support those services.

The District provides wastewater service to the Leucadia and Village Park areas of Encinitas and the La Costa area of Carlsbad. The District encompasses 16 square miles and serves approximately 63,000 residents. Wastewater from the District's service area is transported to the Encina Water Pollution Control Facility where it is treated to federally-mandated standards to protect public health. The Encina plant is a regional facility located in Carlsbad that is jointly owned by the District and five other public entities.

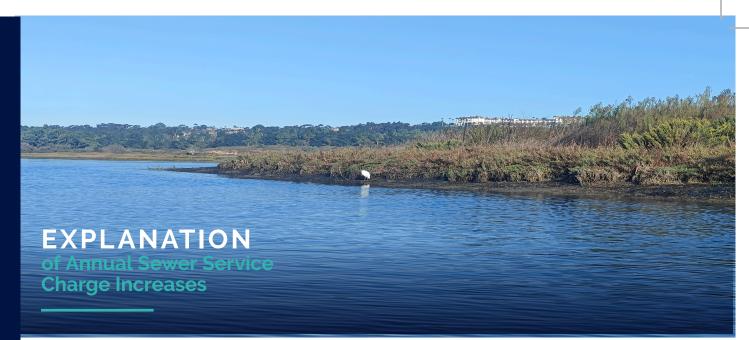

The District also owns and operates the Gafner Water Reclamation Facility, which has a treatment capacity of one million gallons per day. Recycled water produced at the Gafner Facility is sold to the Omni La Costa Resort and Spa to irrigate its Legends' golf course.

The Leucadia Wastewater District proactively plans for increases in costs associated with operations, maintenance, and replacement or rehabilitation of its infrastructure. The District also pays a percentage of the cost to operate and maintain the jointly owned Encina Wastewater Treatment Plant. To cover anticipated cost increases, the District proposes to raise wastewater rates over the next three years.

The District used an engineering firm to develop an Asset Management Plan which determines when capital facilities will need to be replaced, and at what cost. The District used a financial firm to prepare a Financial Plan Study, which projects the District's expenditures and revenues over the next twenty years, and determines the timing of needed rate increases.

The proposed sewer rate increases for the next three years were recommended in the latest Financial Plan Study. These increases are necessary to meet the operations and infrastructure needs of the District. It is anticipated that the District will spend approximately \$61 million for operating (\$29 million) and capital replacement and rehabilitation (\$32 million) costs over the next three years. The District's current sewer service charge is \$38.12 per month, or \$457.42 annually, per household (also called an Equivalent Dwelling Unit or EDU). Currently, the District has one of the lowest sewer service rates in San Diego County. To help keep costs down, the District utilizes a pay as you go methodology, meaning the District collects funds ahead of time to pay for upcoming capital needs and has no financing debt. This helps the District, and its customers save significantly on financing costs and interest expense.

Since the last rate increase, the District has continually inspected its sewer lines and pump stations, and has maintained them in excellent working order. The District's efforts have resulted in a strong record of environmental stewardship. The work completed over the prior three years cost approximately \$47 million in operating (\$24 million) and capital replacement (\$23 million) expenses.

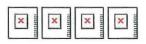

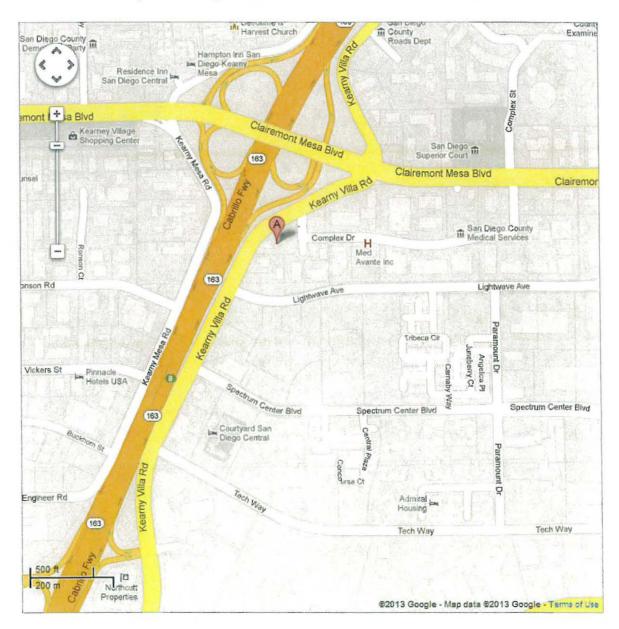

LEUCADIA WASTEWATER DISTRICT QUARTERLY TREASURER'S REPORT SUMMARY As of December 31, 2023

- A. The liquidity of the investments and expected cash flow of the Leucadia Wastewater District (LWD) more than meets expenditure requirements for the next six months.
- B. Our investments are concentrated in five major areas.
 - 1) State of California Local Agency Investment Pool (LAIF): This pool is regulated by the California Government Code under the oversight of the Treasurer of the State of California. This pool is very conservative and its investments are very liquid. District funds are available to us in 24 hours by electronic transfer.
 - 2) San Diego County Treasurer's Pooled Money Fund: This pool is managed by the San Diego County Treasurer-Tax Collector's office. This pool is very conservative and its investments are very liquid. This pool is rated AAAf/S1 by Standard & Poor's. The AAAf rating indicates the extremely strong protection the pool's portfolio investments provide against losses from credit defaults. The S1 volatility rating signifies that the pool possesses low sensitivity to changing market conditions given its low risk profile and conservative investment policies. District funds are available to us in 48 hours by electronic transfer.
 - 3) California Asset Management Program Joint Powers Authority Investment Pool (CAMP): This pool is a short-term investment portfolio for California Public Agencies to invest surplus funds. Public Agencies that invest in the pool purchase shares of beneficial interest. This pool is also very conservative and its investments are very liquid. The CAMP pool is rated AAAm, by Standard & Poor's. This high principal stability rating addresses the ability of the fund to maintain principal value and limit exposure to loss. District funds are available to us in 24 hours by electronic transfer.
 - 4) California Cooperative Liquid Assets Securities System (CLASS): This pool is a short-term investment portfolio for California Public Agencies to invest surplus funds. The pool is overseen by a Board of Trustees comprised of public servants whose agencies invest in the pool. This pool is also very conservative and its investments are very liquid. The CLASS pool is rated AAAm, by Standard & Poor's. District funds are available to us in 24 hours by electronic transfer.

- 5) Securities Purchased Through Financial Broker-Dealers. This category includes US Treasury Bonds and Notes, Federal Agency Securities, Corporate Notes, and Bank Certificates of Deposit (CDs) purchased through a financial broker-dealer and held in a third-party custodial account with Pershing L.L.C. The Certificates of Deposit (CD's) are insured by the Federal Deposit Insurance Corporation (FDIC) or the National Credit Union Administration. (NCUA).
- 6) CAMP Individual Investment Portfolio: The CAMP Individual Portfolio is a professionally managed investment account by separate agreement with CAMP's investment advisor (Public Financial Management, Inc.) and is specifically designed for public agencies. The CAMP Individual Portfolio was initiated in December 2004 and initial investment purchases commenced in January 2005. Investments purchased through the CAMP Individual Portfolio are held by US Bank in a safekeeping trust account. Investments are paid for only upon delivery by the brokerage house with the approval of the District's General Manager. All sales or maturities have cash deposited directly to the safekeeping trust account. No board member, staff member or anyone other than the broker or the bank ever has possession of negotiable investment instruments such as stock or bond certificates. Investments in this area are made to attempt to enhance our overall interest and investment income.
- C. These investments and all investment actions executed since the last quarterly treasurer's investment report comply with California Government Code and with LWD's investment policy.

Pooled Money Investment Account Monthly Portfolio Composition ⁽¹⁾ 12/31/23 \$158.0 billion

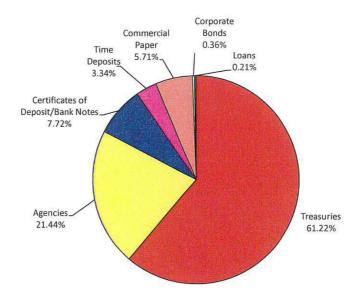

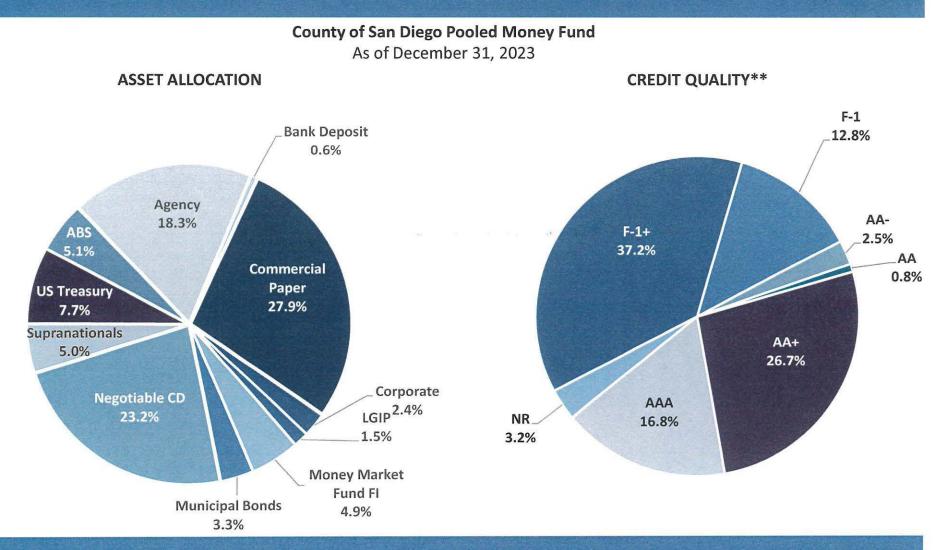

The County Treasurer believes the Treasury Investment Pool contains sufficient cash flow from liquid and maturing securities, bank deposits, and incoming cash to meet the next six months of expected expenditures.

While Safety, Liquidity, and Yield remain the Fund's primary investment objectives, all else being equal and acting under statutory investment limitations, the County Treasurer affirms his/her commitment to the consideration of ESG criteria in evaluating securities. Sustainalytics, a Morningstar Company, provides high-quality, analytical environmental, social and governance (ESG) research, ratings and data to institutional investors and companies. Using Sustainalytics scoring, which is available on Bloomberg, the Pool had a weighted average MTN/CP/CD score of 21.33 as of 12/31/23, placing it in the "Medium Risk" category. Sustainalytics' ratings categories are: negligible (0-9.99), low (10-19.99), medium (20-29.99), high (30-39.99) and severe (40+). 3

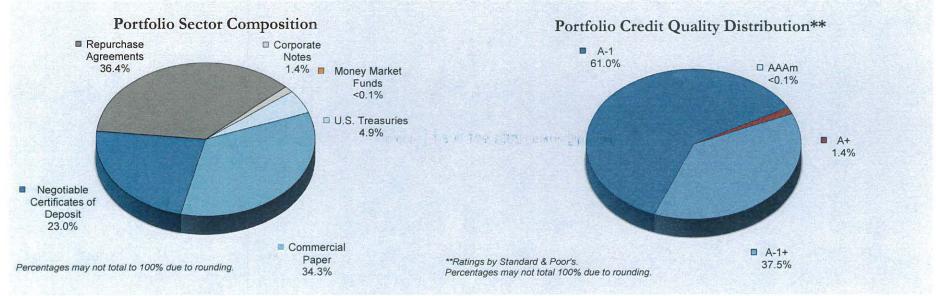

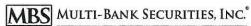
