



It is my pleasure to announce that the Leucadia Wastewater District (LWD) had a successful evening at the recent California Water Environment Association (CWEA) - San Diego Section's Annual Installation and Awards Banquet. LWD was honored to receive the following two awards: the Community Engagement & Outreach Award - Small Budget and the Collection System Person of the Year. A brief summary of each award follows:

Community Engagement & Outreach Award - Small Budget

This award recognizes Leucadia Wastewater District's "No Wipes Down the Pipes" campaign. The objective of this program is to tell customers not to flush the flushable wipes down the toilet and educate our customers and the general public about the damage that "Flushable Wipes" are causing to LWD's pump stations and equipment and how they may cause a blockage in homeowner's sewer laterals. LWD used several methods to reach LWD's customers as well the general public. To reach our customers LWD mailed over 20,000 of LWD's Fall 2015 Newsletter that featured a cover article titled "No Wipes Down the Pipes!" A few weeks later, LWD hired a direct marketing company that hand delivered "No Wipes Down the Pipes!" door hangers to residents within the service area. While these methods focused on reaching our customers, LWD also used other methods to reach the general public. LWD used its Facebook page to post messages informing the public about the harmful effects of flushable wipes in collection systems and in homeowner's sewer laterals. LWD also placed magnetic signs displaying the No Wipes Down the Pipes message on 11 of LWD's vehicles.

LWD also participated in a local environmental community event that featured a display board informing the general public not to flush the "flushable" or disposal wipes down the toilet. For future community events and for customers that visit our office, we have purchased refrigerator magnets to remind customers not to dispose wipes down the toilet.

The Community Engagement & Outreach Award gualifies as a local award under the organization objectives of the LWD's Incentive Program: therefore, staff is eligible for a \$100 incentive award.

Collection System Person of the Year Award

Mr. Todd Amos, a Field Service Technician III, received the Collection System Person of the Year Award. Todd has been employed at LWD since 2012. In achieving this award, the selection committee recognized the fact that Todd is reliable and a technology wizard. As a result, he was assigned as the lead person of several Closed Circuit Television (CCTV) inspection projects throughout the District. His attention to detail, communication skills, and "can do" attitude resulted in the inspection projects being successfully completed.

Please join me in congratulating Todd and LWD as a whole for these outstanding accomplishments. Both awards will move on to the CWEA's statewide competition, which will be announced at CWEA's Annual Conference in April located in Santa Clara, CA.

Minutes of an Engineering Committee Meeting January 12, 2016

A meeting of the Engineering Committee (EC) of Leucadia Wastewater District (LWD) was held on Tuesday, January 12, 2016 at 8:30 a.m., at the LWD Administration Office located at 1960 La Costa Avenue, Carlsbad, California.

1. Call to Order

Chairperson Juliussen called the meeting to order at 8:30 a.m.

2. Roll Call

DIRECTORS PRESENT: DIRECTORS ABSENT: OTHERS PRESENT: Juliussen and Kulchin None General Manager Paul Bushee; Technical Services Manager Robin Morishita; Field Services Superintendent Jeffery Stecker; and Jamie Fagnant from Infrastructure Engineering Corporation.

5. Information Items

A. Saxony Pump Station Rehabilitation Project

TSM Morishita presented a status update of the Saxony Pump Station Rehabilitation Project. He stated that TC Construction is installing the pump station bypass system. He continued that bypassing the pump station is necessary to complete various phases of the project, including the recoating of the wet well and replacing the valve vault piping and valves. TSM Morishita said that installation and testing of the bypass system is scheduled to be completed by the end of the week.

B. Scott's Valley Pipeline Rehabilitation Project

TSM Morishita presented a project update. He said that the liner for the Cured-in-Place Manhole (CIPM) lining of last manhole has been measured and ordered by Sancon. He continued that Sancon has started the rehabilitation of the six manholes in Circulo Adorno and is estimated to be completed by Friday, January 15th.

C. Leucadia (L1) Force Main West Section Replacement Project

Jamie Fagnant presented an update of the L1 Force Main Project design. She stated that the project incorporates the recommendations from the District's Hazard Mitigation Plan (HMP). She continued that flexible expansion joints will be installed

at both ends of the La Costa Avenue bridge crossing over the railroad. Ms. Fagnant said that the extreme western section of the force main east of the railroad bridge will be moved to the south side of La Costa Avenue away from the cliff and constructed with fused pipe to prevent damage in the event of a cliff failure. The EC was satisfied that the design incorporated recommendations from the HMP.

D. Update on LWD's Environmental Performance

GM Bushee presented an update of the District's environmental performance over the past 10 years comparing the most recent 5 years with the previous 5. He stated that the total number of Sewer System Overflows (SSOs) decreased from 16 SSOs between 2006 and 2010 to 7 SSOs between 2011 and 2015. He said that comparing only gravity line SSOs, the number dropped from thirteen SSOs between 2006 and 2010 to three SSOs between 2011 and 2015. GM Bushee attributed this significant improvement to several factors including strong Board support, the shift in focus from hydro-cleaning to Closed Circuit Television (CCTV) inspections, enhanced recruitment process, and the procurement of new equipment.

Director Kulchin suggested that an article be developed using the data presented to inform the general public of the District's success in reducing SSOs to protect the environment and public health. GM Bushee responded that staff will take action on the suggestion.

The EC was pleased with the reported results.

GM Bushee informed the EC that the Request for Proposals for Public Information Services resulted in proposal submissions from seven firms. He continued that four firms have been short listed for interviews to be conducted at the end of January.

16. 2016 Board of Directors Committee Assignments

Director Kulchin also stated that he would like to continue serving on LWD's Engineering Committee.

Director Sullivan indicated the she would like to continue to serve on the EWA Board. She noted that EWA's general manager is leaving the organization and that it is very important to have continuity on the EWA Board during this management transition.

The Board discussed the committee appointments at length. Vice President Hanson noted that she is interested in serving on the EWA Board and that she was previously unable to serve because of her employment status with the City of Encinitas and the associated potential for conflict of interest. She added that now that she is retired there is no conflict.

Following discussion, the Board asked GC Brechtel for clarification on LWD's policy on this issue. GC Brechtel explained that according to the District's Board/Staff Relations policy, the President appoints the committee assignments unless two Board members request for a vote. If two Board members request a vote then the entire Board votes on whether to uphold or not uphold the appointments.

He also provided the results of the number of gravity SSOs. GM Bushee attributed this significant improvement to several factors including strong Board support, the shift in focus from hydro-cleaning to Closed Circuit Television (CCTV) inspections, enhanced recruitment process, and the procurement of new equipment.

Director Sullivan noted that the Board trusts LWD's dedicated employees and how the employees make protecting the environment their number one job. She stated it is easy to support decisions made by staff based on this trust and the presentations that staff make to the Board.

President Omsted asked GM Bushee to explain to the Board how impressed the instructor from Haaker and FSSup Stecker were with the Field Services staff during the training for the new vactor truck. GM Bushee explained that they were impressed with

FS staff engagement during the training and the complexity of their questions to the instructor.

Director Kulchin recommended that an article be written for the newsletter that portrays LWD's excellent environmental record. GM Bushee agreed to do so.

A meeting of the Engineering Committee (EC) of Leucadia Wastewater District (LWD) was held on Wednesday, February 3, 2016 at 8:30 a.m., at the LWD Administration Office located at 1960 La Costa Avenue, Carlsbad, California.

5. Information Items

A. <u>Saxony Pump Station Rehabilitation Project</u>

TSM Morishita presented a status update of the Saxony Pump Station Rehabilitation Project. He stated that the installation and adhesion testing of the wet well epoxy liner was completed. He continued that TC Construction will install the new Automatic Transfer Switch (ATS) on Wednesday, February 3rd. TSM Morishita said that TC Construction has inspected the District supplied submersible chopper pumps for installation.

B. Scott's Valley Pipeline Rehabilitation Project

TSM Morishita presented a project update. He said project construction has been completed. He explained how the adhesion test is conducted on the epoxy manhole liner. He stated that a site visit with Carlsbad Parks & Recreation and the Las Olas Court Homeowner's Association is being coordinated to inspect the condition of the trail and new gates. TSM Morishita also stated that project close out is continuing.

C. Leucadia (L1) Force Main West Section Replacement Project

TSM Morishita presented the status of the L1 Force Main project design. He stated that the cured-in-place pipe (CIPP) lining of the gravity line that runs in La Costa Avenue west of Interstate 5 (I-5) then adjacent to the southbound I-5 onramp

and crosses under I-5 will be incorporated into the L1 project. TSM Morishita explained that the CIPP lining was part of the FY 2016 Gravity Pipeline Rehabilitation Project. He said that shifting the work to the L1 Project will streamline Caltrans permitting from two permits to one permit.

D. <u>Gravity Pipeline Repair Priority List procedure update</u>

FSSup Gonzalez presented an update of the Gravity Pipeline Repair Priority List (RPL) procedure. He explained how the procedure has been implemented within the Field Services department. He stated that the Field Services Technicians like the process because it utilizes their Closed Circuit Television (CCTV) work to develop the capital improvement project for gravity pipeline rehabilitation, repair and replacement. FSSup Gonzalez stated how the RPL procedure has reduced Sewer System Overflows (SSOs) since its implementation.

Director Kulchin asked how does this differ from field service operations conducted five years ago? FSSup Gonzalez answered that five years ago the focus was on hydro-cleaning. He continued that hydro-cleaning was not as effective as visual inspection for condition assessment of the gravity lines in maintaining collection system integrity. FSSup Gonzalez said that prior to implementation of the RPL process the field services staff had little input on gravity pipeline projects.

The EC was pleased with the report.

6. Directors' Comments

Director Kulchin recommended that an Engineering Committee meeting be scheduled on a recurring basis on the first Wednesday of every month. He continued that this will remove the need to coordinate the scheduling of a meeting every month. He said that if a meeting is not necessary, it can be canceled for that month.

Chairperson Juliussen and GM Bushee concurred with the recommendation.

Leucadia Wastewater District Revenue FY 2016


YTD through January 31, 2016


Leucadia Wastewater District **Operating Expenses FY 2016**



Leucadia Wastewater District Capital Expenditures As of January 31, 2016











DISCUSSION:

On September 13, 1995, Leucadia Wastewater District approved Resolution No. 2027 adopting the Fair Political Practices Commission's Standard Model Conflict of Interest Code. Since then, the Board has periodically updated the Code as required. The District last amended the Code and Appendix A on August 15, 2012 when the Board adopted Resolution No. 2226.

The Leucadia Wastewater District (LWD) is required by California Code to biennially review its Conflict of Interest Code (CIC). No amendments were necessary during the 2014 review. However, staff recently reviewed and determined that an amendment to designated positions listed in Appendix A are required. The specific change includes:

Adding the Administrative Services Supervisor designation

Resolution No. 2271 (Attachment 1) and LWD's proposed Conflict of Interest Code (Attachment 2) are attached for the Board's review. If approved, Resolution No. 2271 will rescind all previously adopted resolutions approving LWD Conflict of Interest Codes and adopt in their place the proposed code contained in Attachment 2. LWD Counsel has reviewed both attachments.

Staff therefore recommends that the Board of Directors adopt Resolution No. 2271 updating and revising LWD's Conflict of Interest Code.

CONFLICT OF INTEREST CODE OF THE LEUCADIA WASTEWATER DISTRICT

The Political Reform Act of 1974 (Government Code Section 81000, et seq.) requires each state and local government agency to adopt and promulgate a conflict of interest code. The Fair Political Practices Commission (FPPC) has adopted a regulation, California Code of Regulations, Title 2, Division 6, Section 18730 (hereinafter "CCR 18730"), which contains the terms of a standard conflict of interest code. It can be incorporated by reference as an agency's code. After public notice and hearing, the regulation may be amended by the FPPC to conform to amendments in the Political Reform Act.

Therefore, the terms of Title 2, Division 6 of the California Code of Regulations Section 18730 and any future amendments to it duly adopted by the FPPC are hereby adopted and incorporated herein by reference. This regulation and the Appendix attached hereto designating officials and employees and establishing disclosure categories shall constitute the Conflict of Interest Code of the Leucadia Wastewater District. This code shall take effect when approved by the Board of Supervisors for the County of San Diego, and shall thereupon supersede all prior codes adopted by the Leucadia Wastewater District.

Pursuant to Section 4 of the standard code, designated employees shall file statements of economic interests with the Secretary of the Leucadia Wastewater District. Upon receipt of the statements of the members of the Board of Directors and the General Manager, the Secretary shall make and retain copies and forward the originals of these statements to the Clerk of the San Diego County Board of Supervisors. The Leucadia Wastewater District shall retain statements for all other designated employees. Statements submitted by candidates for elected office shall be filed with the Secretary of the District on or before the deadline for filing the Declaration of Candidacy forms with the Registrar of Voters. The Leucadia Wastewater District shall also retain these statements.

APPENDIX A

AMENDED CONFLICT OF INTEREST CODE OF LEUCADIA WASTEWATER DISTRICT

DESIGNATED POSITIONS

All District officials who manage the investment of public funds are included in and governed by this Conflict of Interest Code only with respect to its disqualification provisions. For purposes of disclosure, all District officials who manage the investment of public funds are governed by the statutory conflict of interest provisions of Article 2 of Chapter 7 of the Political Reform Act of 1974. (Government Code Section 87200, et seq.)

The persons holding positions listed below are "designated employees" who are subject to the provisions of this Code. Each such designated employee is required to disclose interests only in those categories set forth, which are identified by the numbers following his or her title.

Disclosure Categories

The disclosure categories listed below identify the types of investments, business entities, sources of income, or real property that the designated employee must disclose for each disclosure category to which he or she is assigned.

<u>Category I</u>: All investments and business positions in, and sources of income from, all business entities that do business or own real property in the District, plan to do business or own real property in the District within the next year or have done business or owned real property in the District within the past two years.

<u>Category 2</u>: All interest in real property which is located in whole or in part within, or not more than two (2) miles outside, the boundaries of the District.

<u>Category 3</u>: All investments and business positions in, and sources of income from, business entities subject to the regulatory, permit or licensing authority of the Designated Employee's Department, will be subject to such authority within the next year or have been subject to such authority within the past two years.

<u>Category 4</u>: All investments in, and sources of income from, business entities that are engaged in land development, construction or the acquisition or sale of real property in the District, plan to engage in such activities in the District within the next year or have engaged in such activities in the District within the past two years.

<u>Category 5</u>: All investments and business positions in, and sources of income from, business entities that are banking, savings and loan or other financial institutions.

<u>Category 6</u>: All investments and business positions in, and sources of income from, business entities that provide services, supplies, materials, machinery or equipment of a type purchased or leased by the District.

<u>Category 7</u>: All investments and business positions in, and sources of income from, business entities that provide services, supplies, materials, machinery or equipment of a type used or administered by the Designated Employee's Department.

* Consultants shall not be required to file disclosure statements where they: (a) conduct research and arrive at conclusions with respect to rendition of information, advice, recommendation or counsel independent of control and direction of the agency or any agency official other than normal contract monitoring; and (b) possess no authority with respect to any agency decision beyond the rendition of information, advice, recommendation or counsel. The determination as to whether a consultant shall be required to file a disclosure statement shall be made by the General Manager or his or her designee.

DISCUSSION:

Tactical Goal: Financial / Finance Policy Reviews

This item will be reviewed by the IFC at its February 9, 2016 meeting and staff will forward their recommendation to the Board for approval.

In February 2005, the Board of Directors (Board) adopted Leucadia Wastewater District's (LWD) Reserve Fund Policy which established a means for the District to ensure that sufficient funds are available for current operating and capital needs. The policy was last revised in February 2014.

The Reserve Fund Policy establishes two distinct reserves at LWD: 1) Restricted Reserves and 2) Unrestricted Reserves. The policy also establishes various designations within each type of reserve and calls for an annual review of the reserve balances. This report constitutes that review.

During December 2015, the Board received the Comprehensive Annual Financial Report (CAFR) for the fiscal year ended June 30, 2015 that included the following reserve balances:

LEUCADIA WASTEWATER DISTRICT RESERVE FUND POLICY

Ref: 14-3948

A. POLICY STATEMENT:

One key element of prudent financial planning is to ensure that sufficient funding is available for current operating, capital and debt service cost needs. An additional critical element of fiscal responsibility is to anticipate and prepare for future funding requirements as well as for unforeseen disasters and other unforeseen events. The Leucadia Wastewater District (LWD) will at all times strive to have sufficient funding available to meet its operating, capital, and debt service cost obligations. Reserve funds will be accumulated and maintained in a manner, which allows LWD to fund costs consistent with LWD's Long Range Capital Plan and Long Range Financial Plan while avoiding significant rate fluctuations due to changes in cash flow requirements. LWD will also maintain an emergency reserve position that may be utilized to fund unexpected disasters or unanticipated major failures. The Board of Directors will annually review the level of reserve funds maintained.

B. **DEFINITIONS**:

<u>Restricted Reserves:</u> Restrictions on their use are imposed by an outside source such as creditors, grantors, contributors, or laws or regulations of other governments.

<u>Unrestricted Reserves</u>: Have no externally imposed use restriction. The use of Unrestricted Reserve funds is at the discretion of the Board of Directors. There are two categories of Unrestricted Reserves -Designated and Undesignated. At LWD, all Unrestricted Reserves are Designated Reserves.

<u>Designated Reserves</u>: Set-aside for a specific purpose, which is, determined by the Board of Directors. The Board of Directors also has the authority to redirect the use of these reserve funds as needs of LWD change.

C. LEUCADIA WASTEWATER DISTRICT RESERVES:

LWD maintains the following reserve funds:

1.0 **RESTRICTED RESERVES:**

a) Capital Improvement Reserve:

The purpose of the Capital Improvement Reserve is to finance future capital facilities that are expansion /growth related. These capital improvements are identified in LWD's Asset Management Plan and Comprehensive Financial Plan Update. These reserve funds are accumulated in an orderly manner in conformance with State law and drawn down as required by growth related capital projects.

2.0 UNRESTRICTED DESIGNATED RESERVES:

a) <u>Operating Reserve:</u>

Since the majority of operating revenues are received periodically over the fiscal year and operating expenses are incurred uniformly over the fiscal year, an operating reserve is necessary to fund those costs attributable to daily operations. To meet daily operational needs LWD has established an Operating Reserve balance at 33% of annual operating expenses.

G:\ADMIN\Policies\Reserve & Investment Policies\Reserve Policy (Reviewed 02.10.16)

b) Replacement Reserve:

The Replacement Reserve provides funds for capital replacement and refurbishment of existing facilities. These capital improvements are identified in LWD's Asset Management Plan and Comprehensive Financial Plan Update. Replacement reserve funds are accumulated in an orderly manner and drawn down as required to fund capital replacement projects. To avoid abrupt sewer service rate changes, this reserve may be used to stabilize rates. The Replacement Reserve shall not exceed the 20-year capital replacement costs as identified in the Comprehensive Financial Plan Update.

LWD's capacity fee represents a system buy-in that takes into account the value of existing capacity pre-built by current users that will benefit future users, and is a source of funding for the Replacement Reserve.

d) Water Recycling Reserve:

The Water Recycling Reserve will fund capital improvements and replacement of water recycling facilities. This reserve will also be used to fund operating expenses in the Water Recycling Fund whenever there is a shortfall of recycled wastewater sales revenue to operating expenses. These capital improvements are identified in LWD'S Asset Management Plan and Comprehensive Financial Plan Update. The Replacement Reserve shall not exceed the 20-year capital replacement costs as identified in the Comprehensive Financial Plan Update.

e) <u>Emergency Reserve:</u>

The Emergency Reserve provides funds for emergency response for potential repair or replacement of capital facilities due to damage from a natural disaster or unanticipated major failure in a period when capital improvements funds have otherwise been purposely spent down to preset limits on planned projects. The Emergency Reserve is at the discretion of the Board of Directors and is maintained at a level of \$7,500,000, which is based on the recommendation by LWD staff and the District Engineer (Exhibit A).

Leucadia Wastewater District Discussion of Emergency Reserve Fund

Maintenance of an Emergency Reserve Fund (ERF) would provide the benefit of providing funds for emergency response for repair or replacement of capital facilities potentially necessary due to natural disaster damage or unanticipated major failure in a period when capital improvement funds have otherwise been purposely spent down to preset limits on planned projects. Separately, Capital Reserve Funds will be accumulated in a planned manner through financing, setting aside a portion of sewer service fees, or a combination of both methods, as determined by Board policy.

The amount to be recommended for maintenance in the ERF has been evaluated and discussed by Leucadia Wastewater District (LWD) staff and the District Engineer. The following table lists some pros and cons for three potential levels of ERF.

Tactical Goal: Financial Plan Update

During 2013, Leucadia Wastewater District (LWD) updated its Comprehensive Financial Plan. The purpose of this plan is to ensure the financial stability of the District through a long-term financial planning process that projects future financial conditions and provides guidance in our decision-making process.

Each year, following the completion of our annual audit, staff updates the financial model using audited figures. Staff has completed this year's internal update and will present an overview of how LWD is tracking with the Comprehensive Financial Plan.

Staff requests that the Board of Directors:

1) Discuss and provide direction, as appropriate

DISCUSSION

At last month's Board meeting, there were several questions pertaining to Confidence Consulting's fees that were listed in the demands. It was agreed, that this issue would be placed on the February 2016 Board agenda for further discussion. This item serves as the follow-up to January's discussion.

More specifically, there was a question regarding the \$19,752 in fees paid to Confidence Consulting that were listed in the demands. The breakdown of the services provided for the associated fees are as follows:

Services Provided	Fees
All Hands Teambuilding Session (October)	\$3,816.89
Management Team Coaching (November)	\$3,167.60
Employee Satisfaction Survey (December)	\$12,767.53
Total	\$19,752.02

By way of background, the Board of Directors approved a services agreement with Confidence Consulting in September 2012. The agreement called for a retention expense of \$3,000 per month plus expenses. Last year, several Board members expressed concern with the retention component of the agreement from the perspective that paying fees in times where no services were provided did not seem appropriate. As a result, staff informed the Board in late May that the retention agreement would be terminated and that staff would utilize Confidence Consulting's services in a task based approach within the General Manager's signature authority. The retention agreement called for a 30 day written notice to terminate and this notice was provided in June 2015.

Staff also indicated, during the Board's review of the FY 2016 Tactics & Action Plan, that key items under the "People" Strategic Focus area included the all hands teambuilding session and the employee satisfaction survey. Staff executed a task based agreement with Confidence Consulting that included the aforementioned items as well as some limited management coaching. A copy of the agreement has been attached for your review.

To date, the District has spent approximately \$27,000 in management support fees during FY 2016. This amount is for services that are part of the attached agreement plus remaining fees from the previous retention agreement that extended into FY 2016 due to the 30 day cancellation notice. The fees are within the FY 2016 Budget amount for these services.

This item is placed on today's agenda for the Board's discussion and to provide direction, as appropriate.

PROFESSIONAL SERVICES AGREEMENT BETWEEN THE LEUCADIA WASTEWATER DISTRICT AND CONFIDENCE CONSULTING FOR TEAMBUILDING SERVICES

16-4716

This Professional Services Agreement ("Agreement") is made on this 24th day of September, 2015, between the LEUCADIA WASTEWATER DISTRICT ("DISTRICT"), and CONFIDENCE CONSULTING ("CONSULTANT"), an independent contractor, with a principal place of business in Provo, Utah.

ARTICLE 1. TERM OF CONTRACT

1.01. This Agreement will become retroactively effective on July 15, 2015 and will continue in effect until either all services are completed as described in Attachment A,Scope of Services or terminated as provided under Article 7.

ARTICLE 2. SERVICES TO BE PERFORMED BY CONSULTANT

Specific Services

2.01. CONSULTANT will perform the deliverables within the scope described in Attachment A, Scope of Work. CONSULTANT will provide DISTRICT with periodic reports regarding the progress of services performed, at the DISTRICT's request. Any changes to the scope of services or timeframes identified in Attachment A must be authorized by the DISTRICT in writing.

2.02. CONSULTANT will determine the method, details, and means of performing the above-described services.

Status of CONSULTANT

2.03. CONSULTANT and its employee(s) are engaged in an independent contractor relationship with DISTRICT in performing all work, duties and obligations hereunder. DISTRICT shall not exercise any control or direction over the methods by which CONSULTANT shall perform its work and functions. DISTRICT's sole interest and responsibility is to ensure that the services covered by this Agreement are performed and rendered in a competent, satisfactory and legal manner. The parties agree that no work, act, commission or omission of CONSULTANT or its employee(s) pursuant to this Agreement shall be construed to make CONSULTANT or its employee(s) the agent, employee or servant of DISTRICT. CONSULTANT and its employee(s) are not entitled to receive from DISTRICT vacation pay, sick leave, retirement benefits, Social Security, workers' compensation, disability benefits, unemployment benefits or any other employee benefit of any kind.

Payment of Income Taxes

2.04. CONSULTANT shall be solely responsible for paying all federal and state employment and income taxes, for carrying workers' compensation insurance and for otherwise complying with all other employment law requirements with respect to CONSULTANT or its employee(s).

2.05. Relating solely to the payment of taxes, CONSULTANT agrees to indemnify, defend and hold DISTRICT harmless from any and all liability, damages or losses (including attorneys' fees, costs, penalties and fines) DISTRICT suffers as a result of (a) CONSULTANT's failure to meet is obligations under paragraph 2.04, or (b) a third party's designation of CONSULTANT or its employee as an employee of DISTRICT, regardless of any actual or alleged negligence by DISTRICT.

Compliance with Laws/Rules

2.06. CONSULTANT will perform all services under this agreement in good faith and in the best interests of DISTRICT. In performing the services specified in this Agreement, CONSULTANT agrees to comply with all federal and state laws, rules and regulations, applicable DISTRICT policies and procedures, departmental rules and other directives applicable to the services to be performed. Any changes to DISTRICT policies and procedures that relate to CONSULTANT will be provided to CONSULTANT in writing. CONSULTANT agrees to review such policies, procedures, rules and directives the contents of which CONSULTANT will be deemed to have knowledge.

ARTICLE 3

PROJECT TEAM

3.01 DISTRICT has a primary interest in maintaining the individual services of the following key project team member:

1. Jeff K. Bills

No member of the project team shall be removed from the project team or reassigned by CONSULTANT without prior approval of DISTRICT. Such approval shall not be unreasonably withheld or delayed. The CONSULTANT shall be required to immediately inform the DISTRICT should any of the key members become unavailable. The credentials for substitutes for key project members must be submitted to the DISTRICT for review and approval. An interview may also be required if so desired by the DISTRICT.

ARTICLE 4 COMPENSATION

4.01 Compensation for all work performed under this Agreement shall be on a task basis for the services described in Attachment A and shall not exceed <u>\$22,400</u> plus incidental expenses. The parties agree that this compensation was developed in accordance with the customary and prevailing compensation level in the community and surrounding area for comparable services. CONSULTANT and DISTRICT agree that this fee was arrived at through arm's length negotiations between the parties.

Payment of Expenses

4.02 DISTRICT will reimburse CONSULTANT for all reasonable expenses incurred in performing services under this Agreement as the work progresses. CONSULTANT shall submit invoices to the DISTRICT'S Project Manager. Such invoices shall include a brief narrative description of the work performed, as well as detailed time expenditures on a task by task basis pursuant to Attachment A. The term "incidental expenses" means travel expenses approved by the District, telephone bills, federal express charges, mailing charges and any other <u>pre-approved expenses</u> by DISTRICT. CONSULTANT will provide DISTRICT with receipts for all

expenses. DISTRICT shall make payment to CONSULTANT within forty-five (45) days of receipt of approved invoice. Payment provision for any service other than those described in Attachment A will be set forth in an amendment to the Agreement.

ARTICLE 5 OBLIGATIONS OF CONSULTANT

Non-Exclusive Relationship

5.01 CONSULTANT may represent, perform services for, and contract with as many additional clients, persons, or companies as CONSULTANT, in its sole discretion, sees fit.

Tools, Materials, and Equipment

5.02 CONSULTANT will supply all tools materials, and equipment required to perform the services under this Agreement.

CONSULTANT's Qualifications

5.03 CONSULTANT represents that its employee(s) has the qualifications and skills necessary to perform the services under this Agreement in a competent, professional manner, without the advice or direction of DISTRICT. This means CONSULTANT is able to fulfill the requirements of this Agreement. Failure to perform all the services required under this Agreement constitutes a material breach of the Agreement. CONSULTANT has complete and sole discretion for the manner in which the work under this Agreement will be performed.

Indemnity

5.04 CONSULTANT agrees to indemnify, defend, and hold DISTRICT and its officials, officers, directors, agents and employees free and harmless from all claims, demands, losses, costs, expenses, obligations, liabilities, damages, recoveries, and deficiencies, including for bodily injury and property damage, interest, penalties, attorneys' fees, litigation expenses and costs that such entities or persons may incur as a result of any negligent act or omission by CONSULTANT or a breach by CONSULTANT of any representation or agreement contained in this Agreement.

Conflict of Interest

5.05 Upon the award of this Contract and periodically thereafter, CONSULTANT may be required to complete and file with the DISTRICT a Conflict of Interest form, to be provided to CONSULTANT by DISTRICT.

Assignment

5.06 Neither this Agreement nor any duties or obligations under this Agreement may be assigned by CONSULTANT without the prior written consent of DISTRICT.

ARTICLE 6 OBLIGATIONS OF DISTRICT

6.01 DISTRICT agrees to comply with all reasonable requests of CONSULTANT and provide access to all documents reasonably necessary to the performance of CONSULTANT's duties under this Agreement.

Indemnity

6.02 DISTRICT agrees to indemnify, defend, and hold CONSULTANT and its officials, officers, directors, agents and employees free and harmless from all claims, demands, losses, costs, expenses, obligations, liabilities, damages, recoveries, and deficiencies, including for bodily injury and property damage, interest, penalties, attorneys' fees, litigation expenses and costs that such entities or persons may incur as a result of any negligent act or omission by DISTRICT or breach by DISTRICT of any representation or agreement contained in this Agreement.

ARTICLE 7 TERMINATION OF AGREEMENT

Termination for Default

7.01 If either party defaults in the performance of this Agreement or materially breaches any of its provisions, the non-breaching party may immediately terminate this Agreement by giving written notification to the breaching party. Termination will take effect immediately on receipt of notice by the breaching party or five (5) calendar days after mailing of notice, whichever occurs first. For the purposes of this paragraph, material breach of this Agreement includes, but is not limited to, the following:

7.01.1 CONSULTANT's failure to complete the services specified in Article 2 of this Agreement.

7.01.2 CONSULTANT's material breach of any representation or term contained in this Agreement.

7.01.3 DISTRICT's material breach of any representation or agreement contained in this Agreement.

Termination Without Cause

7.02 EITHER party may terminate or abandon any portion or all of the work without cause by giving thirty (30) calendar days written notice. Notice shall be delivered by certified mail, return receipt requested. In such event, EITHER party shall negotiate a revision to the compensation based on documentation of work completed to-date, however, no amount shall be allowed for anticipated profits or unperformed services. Upon termination of the agreement, DISTRICT will be given immediate title to all written data, original drawings and other documents, developed for that portion of the work for which compensation has been received by CONSULTANT.

Compensation Upon Termination

7.03 Upon termination of this agreement under Sections 7.01 or 7.02 above, DISTRICT will pay to CONSULTANT any outstanding service fees or expenses minus any costs reasonably

incurred by DISTRICT related to CONSULTANT's services under this Agreement prior to the notice of termination.

ARTICLE 8 PROPRIETARY RIGHTS

Confidential Information

8.01 Any written, printed, graphic, or electronically or magnetically recorded information furnished by DISTRICT for CONSULTANT's use are the sole property of DISTRICT. This proprietary information includes, but is not limited to, customer requirements, customer lists, marketing information, and information concerning DISTRICT employees, products, services, prices, operations, and subsidiaries.

8.02 CONSULTANT and its employee(s) will keep this confidential information in the strictest confidence, and will not disclose it by any means to any person except with DISTRICT approval, and only to the extent necessary to perform the services under this Agreement. This prohibition also applies to CONSULTANT's employees, agents, and subcontractors. On termination of this Agreement, CONSULTANT will promptly return any confidential information in its possession to DISTRICT.

ARTICLE 9 GENERAL PROVISIONS

Notices

9.01 Any notices required to be given under this Agreement by either party to the other may be affected by personal delivery in writing or by mail, registered or certified, postage prepaid with return receipt requested. Mailed notices must be addressed to the parties at the addresses below, but each party may change the address by giving written notice in accordance with this paragraph. Notices delivered personally will be deemed communicated as of actual receipt; mailed notices will be deemed communicated as of the day of receipt or the fifth day after mailing, whichever occurs first.

Entire Agreement of the Parties

9.02 This Agreement contains the entire understanding among the parties hereto with respect to the subject matter hereof, and supersedes all prior and contemporaneous agreements and understandings, inducements, or conditions, express or implied, oral or written, except as herein contained. The express terms hereof control and supersede any course of performance and/or usage of the trade inconsistent with any of the terms hereof. This Agreement may not be modified or amended other than by an agreement in writing.

Partial Invalidity

9.03 If any non-material provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remaining provisions will continue in full force and effect without being impaired or invalidated in any way.

Attorneys' Fees

9.04 If any legal action, including an action for declaratory relief, is brought to enforce or interpret the provisions of this Agreement, the prevailing party will be entitled to reasonable attorneys' fees, which may be set by the court in the same action or in a separate action brought for that purpose, in addition to any other relief to which that party may be entitled.

Document and Materials Ownership

9.05 All original drawings, diskettes, and other copies of documents and materials developed for the project, including detailed calculations, shall be furnished to and become the property of DISTRICT. The DISTRICT agrees to indemnify the CONSULTANT for claims, damages, or liabilities caused by any use by the DISTRICT of the plans, drawings, specifications, and all information gathered by the CONSULTANT on any project other than the one for which such plans, drawings, and specifications were prepared and information gathered by the CONSULTANT.

Governing Law

9.06 This Agreement and all questions relating to its validity, interpretation, performance, and enforcement (including, without limitation, provisions concerning limitations of actions), shall be governed by and construed in accordance with the laws of the state of California, notwithstanding any conflict-of-laws doctrines of such state or other jurisdiction to the contrary and without the aid of any canon, custom, or rule of law requiring construction against the draftsman.


