Director Juliussen reported that the EC reviewed an Agreement with Insituform Technologies for construction services to complete the Leucadia Scenic Cured-In-Place Pipe Lining Project in an amount not to exceed \$172,602. He noted that the EC agreed with staff to recommend Board approval of the agreement and it will be reviewed by the Board later in the agenda.

Director Juliussen also reported that the EC reviewed a purchase Agreement with Charles King Company for the purchase of a new trailer mounted engine driven pump in an amount not to exceed \$47,668.78. He noted that the EC agreed with staff to recommend Board approval of the agreement and it will be reviewed by the Board later in the agenda.

Director Juliussen stated that the EC received an update on the Village Park No. 5 Pump Station Replacement Project. This item was for informational purposes only. No action was taken.

Vice President Hanson reported that the committee reviewed the Fiscal Year 2016 (FY16) Comprehensive Annual Finance Report (CAFR) and it will be reviewed by the Board later in the agenda.

16. Leucadia Scenic Cured-In-Place Pipe (CIPP) Lining Project

Authorize the General Manager to execute an Agreement with Insituform Technologies for construction services to complete the Leucadia Scenic CIPP Lining Project in an amount not to exceed \$172,602.

TSM Morishita presented this item stating it was reviewed by the EC at their December 7th meeting. He also noted that it is a Fiscal Year 2017 (FY17) tactical goal. He explained that the project was originally part of the Leucadia (L1) Force Main West Section Replacement Project and was removed and rebid as a stand alone project.

TSM Morishita stated that the project was bid on November 14th and bids were received on November 29th. He stated that three bids were received with Insituform Technologies (Insituform) submitting the lowest bid. TSM Morishita noted that Infrastructure Engineering Corporation (IEC) evaluated the bids and determined that Insituform was the lowest responsive and responsible bidder. TSM Morishita stated that staff and IEC recommended that the contract be awarded to Insituform.

Following discussion, upon a motion duly made by Director Kulchin, seconded by Director Sullivan, and unanimously carried, the Board of Directors authorized the General Manager to execute an Agreement with Insituform Technologies for construction services to complete the Leucadia Scenic CIPP Lining Project in an amount not to exceed \$172,602 by the following vote:

17. Purchase of a Trailer Mounted Engine Driven Pump

Authorize the General Manager to execute a purchase Agreement with Charles King Company (CKC) for the purchase of a new trailer mounted engine driven pump in an amount not to exceed \$47,668.78.

FSSupt Stecker presented this item stating it was reviewed by the EC at their December 7th meeting. He also noted that it is a FY17 tactical goal. FSSupt Stecker stated that the current trailer mounted pump is at the end of its useful life and that the pump will not meet the new Air Pollution Control District emissions requirements that take effect on January 1, 2017. He stated said that staff solicited sealed bids from the three pump manufacturers and received bids from all of them.

(Auditors Jennifer Farr and Shannon Ayala arrived at the meeting at 5:21p.m.)

FSSupt Stecker stated that CKC submitted the lowest bid. He continued that DE Deering evaluated CKC's bid and determined that CKC was the lowest responsive and responsible bidder.

FSSupt Stecker stated that staff and the EC recommend that the purchase of the trailer mounted pump be awarded to CKC. He noted that CKC was the only manufacturer that allowed a trade-in of the existing pump as part of the purchase.

Following discussion, upon a motion duly made by Director Sullivan, seconded by Director Juliussen, and unanimously carried, the Board of Directors authorized the General Manager to execute a purchase Agreement with CKC for the purchase of a new trailer mounted engine driven pump in an amount not to exceed \$47,668.78 by the following vote:

Director Juliussen asked what percentage of LWD's annual service charge rate covers replacement costs.

GM Bushee answered his question stating that LWD's service rate covers about 70 percent of LWD's replacement expenses. GM Bushee noted that the remaining amount of replacement expense is covered by non-operating revenues, primarily the property taxes.

ASM Duffey Introduced Jennifer Farr of Davis Farr, LLP to provide a summary of the auditors' reports and auditing process.

Ms. Farr reviewed the three separate reports issued by Davis Farr, LLP. She provided summaries for the Audit Opinion, the Internal Control Communication, and the Required Auditor Communication reports. She noted that the audit was an unmodified audit opinion noting that the financial statements and disclosures are accurate and there are no material misstatements. She also stated that there were no material weaknesses or significant deficiencies in LWD's internal controls and no material non-compliance noted.

Ms. Farr reviewed the Significant Procedures Performed. She stated that the Financial Statement Changes included one new standard, the implementation of GASB 72 Fair Value Measurement and Application, which added an additional disclosure to the audit.

The Board thanked Ms. Farr for the presentation.

GM Bushee thanked Davis Farr, LLP and staff for their time and hard work in completing the FY16 CAFR.

Minutes of an Engineering Committee Meeting January 4, 2017

A meeting of the Engineering Committee (EC) of Leucadia Wastewater District (LWD) was held on Wednesday, January 4, 2017 at 8:30 a.m., at the LWD Administration Office located at 1960 La Costa Avenue, Carlsbad, California.

1. Call to Order

Chairperson Juliussen called the meeting to order at 8:30 a.m.

2. Roll Call

4. New Business

Leucadia Force Main No.1 (L1) West Section Replacement Project Construction Contract

A. Recommendation 1: <u>Authorize the General Manager to execute an Agreement with</u> <u>CCL Contracting for construction services to complete the Leucadia Force Main No.1</u> (L1) West Section Replacement Project in an amount not to exceed \$1,387,731.

Recommendation 2: <u>Authorize the transfer of funds in the amount of \$200,000 from</u> the FY16 Gravity Pipeline Rehabilitation Construction account and \$95,000 from the FY15 Gravity Pipeline Rehabilitation Construction account for a total amount of \$295,000 to cover the full cost of project construction.

TSM Morishita presented the staff recommendation. He explained that the project was originally part of the Leucadia Force Main No.1 (L1) West Section Replacement Project that bid in early November. He continued that because the District received only two significantly high bids for the project, staff decided to break the project into two separate projects. TSM Morishita stated that the Board approved the contract for the construction of the Leucadia Scenic Cured-In-Place Pipe Lining Project in December. He said that this is a re-bid of the separated Leucadia Force Main No.1 (L1) West Section Replacement Project (L1 Force Main Replacement).

TSM Morishita stated that the project was bid on November 21st and bids were received on December 15th. He said that four bids were received with CCL Contracting, Incorporated (CCL) submitting the lowest bid. He continued that Infrastructure Engineering Corporation (IEC) evaluated the bids and determined that

CCL was the lowest responsive and responsible bidder. TSM Morishita said that IEC recommended and staff concurs that the contract be awarded to CCL.

TSM Morishita explained that separating the projects increased the competitive bid environment which resulted in the District saving 394,217 in total cost for the two separate projects (172,602 + 1,387,731 = 1,560,333) over the original combined project bid of 1,954,550.

TSM Morishita explained that \$295,000 is needed in the construction account for the L1 Force Main Replacement project. He continued that the amount is a result of a \$145,000 construction cost shortfall and a \$150,000 (10%) contingency. He stated that the request is to transfer \$200,000 from the FY16 Gravity Pipeline Rehabilitation Project and \$95,000 from the FY15 Gravity Pipeline Rehabilitation Project. TSM Morishita noted that the \$172,602 Leucadia Scenic Cured-In-Place Pipe Lining Project was originally part of the FY16 Gravity Pipeline Rehabilitation Project.

After discussion, the EC concurred with staff to recommend that the Board authorize executing an agreement with CCL Contracting for construction services and authorize the transfer of funds to complete the Leucadia Force Main No.1 (L1) West Section Replacement Project.

B. <u>Authorize the General Manager to execute an Agreement with Richard Stinson</u> <u>Construction Management for construction management services during the</u> <u>construction of the Leucadia Force Main No.1 (L1) West Section Replacement Project</u> <u>in an amount not to exceed \$50,000.</u>

TSM Morishita presented the staff recommendation. He said that the Leucadia Force Main No.1 (L1) West Section Replacement Project (L1 Force Main Replacement) requires construction management support to oversee construction of the project. He stated that Richard Stinson has a proven track record of providing excellent construction management (CM) services to the District. TSM Morishita said that Mr. Stinson has provided CM services for every collection system construction project undertaken by the District since 2003. He said that Mr. Stinson submitted a proposal to provide CM services in an amount not to exceed \$50,000, an estimated 500 hours at \$100 per hour. He said that staff believes this fee is fair and reasonable.

TSM Morishita said that Mr. Stinson has consistently provided outstanding CM services on previous District projects and possesses in depth knowledge of the District's collection system and operations. TSM Morishita explained that Mr. Stinson performed the constructability review of the L1 Force Main Replacement project during the project's design phase and, therefore, has thorough knowledge of the project's plans and specifications. TSM Morishita said that retaining Mr. Stinson for CM services during construction will provide continuity, efficiency and is in the best interest of the District. TSM Morishita stated that for these reasons, the procurement of these CM services satisfies the criteria for sole sourcing allowed under Section 11.1, Sole Source Procurement, and continuity of service under Section 12.4, Continuing Services, of the District's Procurement Policy.

After discussion, the EC concurred with staff to recommend that the Board authorize the General Manager to execute an agreement with Richard Stinson Construction

Management for construction management services for the Leucadia Force Main No.1 (L1) Replacement Project.

5. Information Items

A. Hazard Mitigation Plan overview

TSM Morishita presented an overview of the District's Hazard Mitigation Plan. He presented this overview in response to Director Kulchin's request regarding the impacts to District assets related to the projected rise in sea level. TSM Morishita stated that the Hazard Preparedness and Mitigation Plan (HPMP) indicated four pump stations; Batiquitos, Leucadia, Saxony and La Costa; may be impacted if sea levels rise as projected by 4.6 feet by the year 2100. He went on to explain the mitigation and preparedness strategies presented in the plan. TSM Morishita emphasized that the Leucadia Force Main No.1 (L1) West Section Replacement Project incorporated recommendations presented in the HPMP.

Upon completion of the overview, Director Kulchin was satisfied that his concern regarding the impact of sea level rise on District's infrastructure has been and will continue to be addressed.






INVESTMENT DISTRIBUTION BY CATEGORY



Recommendation 2: The EC reviewed staff's request to transfer funds in the amount of \$200,000 from the FY16 Gravity Pipeline Rehabilitation Construction account and \$95,000 from the FY15 Gravity Pipeline Rehabilitation Construction account for a total amount of \$295,000 to cover the full cost of project construction.

The EC concurred with staff to present these recommendations to the Board of Directors and it will be discussed later in the agenda.

2. The EC reviewed an Agreement with Richard Stinson Construction Management for construction management services during the construction of the Leucadia Force Main No. 1 (L1) West Section Replacement Project in an amount not to exceed \$50,000.

RECOMMENDATION:

Staff and the Engineering Committee recommend that the Board of Directors:

- 1. Authorize the General Manager to execute an Agreement with CCL Contracting for construction services to complete the Leucadia Force Main No.1 (L1) West Section Replacement Project in an amount not to exceed \$1,387,731.
- 2. Authorize the transfer of funds in the amount of \$200,000 from the FY16 Gravity Pipeline Rehabilitation Construction account and \$95,000 from the FY15 Gravity Pipeline Rehabilitation Construction account for a total amount of \$295,000 to cover the full cost of project construction.
- 3. Discuss and take other action as appropriate.

BACKGROUND:

Tactical Goal: Infrastructure and Technology / L1 Force Main West Section Replacement

This item was reviewed by the EC at its January 4th meeting and the EC concurred with staff to present this item for the Board's consideration.

In July 2013 Infrastructure Engineering Corporation (IEC) completed the Leucadia (L1) Force Main Internal Corrosion Evaluation Project Report. Based on the condition of the sample taken from the L1 section west of Interstate 5, IEC recommended that the District discontinue use of L1 until the District conducted further condition assessments of the force main.

In October 2013, IEC researched ways to conduct the non-destructive assessment of L1. However, due to the significant cost, staff recommended and the Board agreed that the District should not perform the assessment at that time. Instead, staff thought the funds would be better spent replacing the western section of L1. Staff is confident that once the west section is replaced L1 can then be relied on for use during an emergency.

In March 2015, the Board authorized an Agreement with IEC to design the Leucadia Force Main No.1 (L1) West Section Replacement Project (L1 Force Main). Then in July 2015, the Board authorized the execution of an agreement with IEC to design the 2016 Gravity Pipeline Rehabilitation Project which included the Cured-in-Place Pipe (CIPP) lining of the Leucadia Scenic gravity line (Leucadia Scenic). Subsequently, the L1 Force Main and Leucadia Scenic projects were combined into a single project for the following reasons:

- > The requirement to obtain a Caltrans right-of-way (ROW) Permit due to project location.
- Completion of the CIPP lining of the portion of the Leucadia Scenic gravity line in La Costa Avenue for added structural support of that line prior to replacement of the L1 Force Main.
- > Construction scheduling of the CIPP lining and L1 Force Main replacement.

The design for the combined project, including an approved Caltrans ROW Permit, was completed and put out for bids in September 2016. Bids were due on November 3, 2016 and two bids were received. The two bids were significantly higher (39.6% and 61.3%) than the Engineer's Estimate of \$1.4M. As a result of the high bids and minimal competition from the bid solicitation, Staff rejected the two submitted bids and separated the projects with the goal of improving the bid environment and lowering project costs. The Leucadia Scenic construction project was awarded in December 2016 at a cost of \$172,602.

DISCUSSION:

In November 2016, IEC finalized the revised plans and specifications for the Leucadia Force Main No.1 (L1) West Section Replacement Project. The project includes the realignment of a portion of the L1 Force Main to the south side of La Costa Avenue to shift it away from the bluffs to the north to reduce the risk of force main damage in the event of a slope failure. Please refer to the diagram below for the L1 Force Main project location and alignment.



The project was advertised for bids on November 21st with bids due on December 15th. Four bids were received with the following results:

The bids were reviewed by Scott Fleming and Jamie Fagnant at IEC. The bid review memorandum is attached for your review. Based on the required documents submitted with their bid, CCL Contracting (CCL) has the requisite knowledge and experience to perform the work on the project. The bid submitted by CCL was 22.5% lower than the Engineer's Estimate of \$1.79M.

As a result of their evaluation, IEC recommends that CCL be awarded the contract as the lowest responsive and responsible bidder. Staff concurs with IEC's assessment and recommends that the Board award the construction contract for the Leucadia Force Main No.1 (L1) West Section Replacement Project to CCL Contracting in an amount not to exceed \$1,387,731. It should be

noted that the total cost of the two projects is \$1,560,333 or a savings of \$394,217 from the original L1 Force Main and Leucadia Scenic combined project bid of \$1,954,550.

FISCAL IMPACT:

Staff appropriated a total of \$1,416,600 for the L1 West Section Replacement project construction. An additional appropriation of \$295,000 is needed to cover the total construction costs for both the L1 West Section Replacement and Leucadia Scenic projects, including contingency (\$145,000 construction cost shortfall and \$150,000 for 10% project contingency). Staff recommends completing the construction of both projects to ensure the integrity and reliability of the collection system. Therefore, staff requests the Board approve the transfer of funds in the amount of \$200,000 from the FY16 Gravity Pipeline Rehabilitation Construction account and \$95,000 from the FY15 Gravity Pipeline Rehabilitation Construction. It should be noted that the Leucadia Scenic portion of the project (\$172,602) was originally included in the FY16 Pipeline Rehabilitation Project.

PURPOSE

This memorandum provides a summary of our evaluation of bid results and the responsiveness of the submitted bids for the subject project.

BID RESULTS

Four bids were received and opened on December 15th, 2016. The bids are summarized on Table 1 - Bid Summary (see attached) and characteristics of the bids are as follows:

Low Bid (CCL Contracting):	\$1,387,731
2 nd Lowest Bid (S.C. Valley Engineering, Inc.):	\$1,795,000
3 rd Lowest Bid (Burtech Pipeline):	\$1,845,000
High Bid (PAL Engineering):	\$1,938,731
Engineer's Opinion of Probable Cost:	\$1,797,050

This project was originally bid in conjunction with the L1 Leucadia Scenic Cured-in-Place Pipe Lining Project. However, upon review of the bids received it was apparent that inclusion of the lining work as part of the larger force main project resulted in unusually elevated bids and a small pool of bidders. The initial bids on this larger project were rejected and the project repackaged to split the lining portion of the project out from the force main replacement. This resulted in a reduced low bids as shown above.

REVIEW OF LOW BIDDER

CCL Contracting Inc. (CCL or Contractor), Escondido, California, submitted the apparent low bid. IEC has reviewed CCL's bid and recommends the District award the project to CCL for the following reasons:

Contractor's License: The Contractor holds the required Class A License (No. 798819). The license is current and active.

Bid Bond: A bid bond in the amount of ten percent (10%) of the bid amount was submitted with Liberty Mutual Insurance Company as surety. Liberty Mutual Insurance Company has a Best's Key Rating of A, XV

Signatures: The Contractor's Contracting & Attesting Officer, Bryan Lusky signed the Closing Statement and Non-Collusion Affidavit. Bryan Lusky and the Contractor's Attorney-in-Fact, Mark D. Iatarola, signed the Bidder's Bond.

Project Manager's Experience: The Contractor has identified Brian Lusky as the project manager in a follow-up phone call from IEC on 12/16/16.

Approach to Work: The Contractor addressed the anticipated project issues as required in the Approach to Work section of the Bid Documents. IEC followed up with CCL via a phone call on December 16, 2016 to confirm that CCL fully understood the project. Rod Chilcote of CCL confirmed that they were prepared to perform the work for the bid amount provided.

Worker's Compensation Insurance: Policy is in affect through 04/01/2017. The most recent workers' compensation experience modification factor for CCL is 1.07%.

Experience Requirements: The bid documents require the Contractor to submit three project references where the Contractor was required to install at least 2,000 linear feet or greater pipeline using AWWA C905 PVC pipe with a minimum diameter of 14 inches. CCL provided the requisite project references.

References: IEC contacted CCL's listed references to perform an assessment of the Contractor's prior work. In all cases, CCL was recommended as a good contractor with no record of claims.

Registration with the Department of Industrial Relations (DIR):

As of 03/01/2015 contractors and their subcontractors are required to be registered with the DIR prior to bidding a public works project. The table below demonstrates that CCL and each of its subcontractors have met this requirement.

SUBJECT: Leucadia Force Main No.1 (L1) West Section Replacement Project Construction Management Services Contract

RECOMMENDATION:

Staff and the Engineering Committee recommend that the Board of Directors:

- 1. Authorize the General Manager to execute an Agreement with Richard Stinson Construction Management for construction management services during the construction of the Leucadia Force Main No.1 (L1) West Section Replacement Project in an amount not to exceed \$50,000.
- 2. Discuss and take other action as appropriate.

DISCUSSION:

Tactical Goal: Infrastructure and Technology / L1 Force Main West Section Replacement

This item was reviewed by the EC at its January 4th meeting and the EC concurred with staff to present this item for the Board's consideration.

The Leucadia Force Main No.1 (L1) West Section Replacement Project (L1 Force Main) requires construction management support to oversee construction of the project. The construction management services consist of contractor oversight, negotiating change orders, construction inspection and administration. Richard Stinson has a proven track record of providing excellent construction management (CM) services to the District. Mr. Stinson has provided CM services for a majority of the collection system construction projects undertaken by the District since 2003 including the Satellite Pump Stations, Force Mains, and Gravity Sewer Replacement Project, the Batiquitos (B1/B2) Force Main Replacement Project, Batiquitos Pump Station Rehabilitation Project and Fiscal Years 2013, 2014, 2015 and 2016 Gravity Pipeline Rehabilitation Projects. For the L1 Force Main project, Mr. Stinson submitted a proposal to provide CM services in an amount not to exceed \$50,000, an estimated 500 hours at \$100 per hour. Based on the estimated 150 calendar day period for construction and Mr. Stinson's experience and past performance, staff believes this fee is fair and reasonable.

Mr. Stinson has consistently provided outstanding CM services on previous District projects. He possesses in depth knowledge of the District's collection system and operations. Mr. Stinson performed constructability reviews of the L1 Force Main project during the project's design phase and, therefore, has thorough knowledge of the project's plans and specifications. Retaining his CM services during construction will provide continuity, efficiency and is in the best interest of the District. For these reasons, the procurement of these CM services satisfies the criteria for sole

sourcing allowed under Section 11.1, Sole Source Procurement, and continuity of service under Section 12.4, Continuing Services, of the District's Procurement Policy.

The service to be provided by Mr. Stinson will be paid on a time and material basis. Therefore, Staff recommends that the Board award the contract for CM services for the Leucadia Force Main No.1 (L1) West Section Replacement Project to Richard Stinson Construction Management.

FISCAL IMPACT:

Funds for project construction were included in the Fiscal Year 2017 budget. The appropriation is sufficient to cover the project's construction management and inspection costs.
