Overview of Recommended Fiscal Year 2014 (FY14) Budget

RECOMMENDATION:

1. Review and provide direction as appropriate.

DISCUSSION:

Enclosed please find the Recommended FY14 Budget for your review. Staff will present an overview of the proposed budget at the upcoming special Board meeting. Highlights of the budget include:

- 1) The Wastewater Service Charge will remain stable at \$258.21/EDU/YR.
- 2) Expenses are allocated to the following primary programs:
 - a. Wastewater Enterprise
 - b. Batiquitos Pump Station
 - c. Recycled Water Enterprise
 - d. Capital Program
- 3) Administrative service costs have been allocated to the four programs above as overhead.
- 4) Development expenses have been included as a separate program.
- 5) The FY14 Capital Improvement Program Budget includes funding for the Batiquitos (B2) Force Main replacement project, replacement of the Leucadia pump station generator, the La Costa pump station rehabilitation project, repair of the recycled water effluent line, the North County Regional Recycled Water Project, miscellaneous pipeline repairs and the Lateral Replacement Program.

Staff will incorporate feedback from the Board into the final budget scheduled to be considered on June 12, 2013.
