Are you ready for a NATURAL DISASTER?

Natural disasters occur when you least expect them. For this reason, we take proactive steps to prepare for and mitgate damage to our facilities from a wide range of unexpected disasters. During 2015, we developed a Hazard Preparedness and Mitigation Plan. This plan helped us identify potential natural disasters that may occur in our local area, analyzed the possible impacts on our facilities, and provided strategies for preparing and managing each specific disaster.

There are a number of ways our staff prepares for the worst. Earthquakes are one of the potential disasters we could face. With this in mind, we recently added flexible joints and supports to one of our sewer force mains near

the Batiquitos Lagoon. This section of pipe had been exposed, is by the lagoon, and crossed the Amtrak line. We also installed a redundant force main to utilize in case there is damage to one of the other force mains.

Active drills, coordination, and preparation with other local agencies keep our field services and management staff ready to respond to emergencies. We recently partnered with the Encina Wastewater Authority and the cities of Carlsbad and Encinitas to simulate a response to a sewer spill caused by an natural disaster. This level of coordination and joint training helps ensure that if there is a disaster, we can quickly and effectively mobilize to protect our local beaches and lagoons from sewer spills.



Partnering with Other Government Agencies to Help Reduce Costs

The San Diego Association of Governments (SANDAG) and the North County Transit District (NCTD) will construct an underground passenger tunnel to link both sides of the passenger platform at the Poinsettia Train Station in Carlsbad. To accomplish this, the train tracks will be shifted to the west. Since one of our pipelines runs under the train tracks, this project provided us with an opportunity to partner with SANDAG and NCTD. We will be reinforcing the existing pipeline and constructing a second pipeline under the train tracks. This will provide redundancy in the case of an emergency, enhancing our ability to protect the environment in that area. SANDAG and NCTD already have the necessary environmental permits for this project, therefore partnering with them on this project saves the District considerable time and money.

Spotlighted Tour

Congratulations to FIRST Lego League Robotics TRLMBv2 of Sage Canyon and Ocean Airs schools on winning the local FIRST Lego Regional Finals! At a recent Board Meeting, the robotics team presented their project on how wet wipes are impacting the human water cycle by clogging the wastewater system.

These young men took field trips to our Gafner Water Reclamation Facility and toured the Point Loma Wastewater Treatment Plant to see firsthand how despite claims on the labels - wet wipes

do not break down in the sewer system. Their presentation to our Board of Directors was in preparation for a First Lego League Tournament on hydrodynamics. The team completed experiments with 8 different brands of wet wipes to see how well they break down and rated them. They discovered that none of them broke down as well as toilet paper.

Wet Wipes Clog Pipes!

We won't rest easy until we eliminate wet wipes from the sewer system! They get caught up in the pumps, in screens, and in wet wells at our pump stations. They also accumulate Fats, Oils, and Grease (FOG) and other debris that is improperly poured down the drain. Any of this can cause a spill. So if you like clean beaches, low and consistent rates, and clean neighborhoods please remember to use a trash can! #NoWipesDownThePipes





Eliminate Household Odors

Sometimes you'll notice an odor coming from your sink or shower drain that smells like rotten eggs. This could be sewer gas, especially if it's coming from a bathroom sink or drain that isn't used much. Sinks, toilets, and showers all have a "P - Trap" (see illustration) that helps prevent sewer gas from coming back up your pipes and into your home. These traps hold a small amount

of water which helps prevent gases from entering your bathroom or other areas that have drains. When the P - trap is full, any lingering gas travels up a separate pipe that vents through your

roof, keeping it out of your house. If you notice an odor coming from your sink or other drain, run the water for a while to fill the trap. If the problem persists, you may need to get a plumber to check to make sure that your trap & vent are working properly.


